SUMMARY OF SCHEDULED MEETINGS

859th meeting

Opening of the session and adoption of the agenda [1]

The session was opened at its 859th meeting.

The provisional agenda (A/AC.105/C.2/L.288) was adopted.

Statement by the Chair [2]

The Chair made an opening statement outlining the work of the Subcommittee.

Organization of work

The Subcommittee decided to invite the representatives of the Dominican Republic, El Salvador, Guatemala, Israel and the United Arab Emirates and for the European Union to participate in the session as observers.

General exchange of views [3]

The Subcommittee began its consideration of this item with statements by the representatives of Guatemala on behalf of the Latin America and the Caribbean Group, Armenia, Austria, China, Ecuador, Germany, Japan the Republic of Korea and the United States of America.

The Director of the Office for Outer Space Affairs made a statement on the work of the Office.

860th meeting

Symposium

A scientific symposium on the theme "The UNIDROIT Space Protocol" co-organized by the International Institute of Space Law (IISL) and the European Centre for Space Law (ECSL), was held during the 860th session of the Legal Subcommittee. The symposium was co-chaired by Ms. Tanja Masson-Zwaan, President of IISL and Mr. Sergio Marchisio, President of ECSL with a welcome statement made by Mr. Tare Brisibe, Chair of the Legal Subcommittee.

Presentations were made by Mr. Martin Stanford, International Institute for the Unification of Private Law (UNIDROIT), Italy; Mr. Bernhard Schmidt-Tedd, DLR, Germany and Mr. Stephan Hobe, University of Cologne, Germany; Mr. Patrick Phetole Sekhula, South African Council for Space Affairs, South Africa, and Ms. Tanja Masson-Zwaan on behalf of Mr. Chris Johnson of the University of Leiden, the Netherlands.

Concluding remarks were made by the Chair of the Legal Subcommittee and by the Co-Chairs of the Symposium.
