






- ✓ In 2007 INTERSPUTNIK acceded to the Regional Commonwealth in the Field of Communication (RCC) that unites Telecommunications Administrations of CIS, Baltic, Central and Eastern European countries.
- ✓ INTERSPUTNIK's representatives joined in the works of RCC commissions and working groups.

- Working group for the revision of RCC constitutional instruments is entrusted with the elaboration of documents to establish an international intergovernmental organization called "Regional Communications Commonwealth" on the basis of the RCC association.
- ✓ Based on its huge 37 years' managerial, conceptual, technological and legal experience, INTERSPUTNIK is determined to continue assisting the RCC in establishing a new specialized international organization.







ASSISTANCE TO TELECOMMUNICATIONS ADMINISTRATIONS AND SATELLITE OPERATORS

In most cases, Telecommunications Administrations and operators prepare their ITU filings in a way allowing them to be as free as possible in configuring their spacecraft.

Filing global service areas and full-scale frequency bands, they block the frequency resource and prevent new satellite systems from being brought into use.
