
UNOOSA funding model

Annually

• ~USD 5,5 million

Funding sources

- Regular Budget (UN General Assembly)
 - Annually ~ USD 3,5 million
- Extra-Budgetary (Voluntary Cash Contributions)
 - Annually ~ USD 1-1,2 million
 - 90% from governmental sources
- Other (In-kind Contributions)
 - Annually, valued at ~USD1-\$1,2 million




UNOOSA Funding Model



Staff costs

Current workforce: 33, incl. 2 short-term appointments

- Regular budget funds 23 staff positions
- Voluntary cash contributions funds 3 staff positions
 - Austria, China, Germany
- In-kind contributions funds 5 nonreimbursable loans at professional level
 - Approximate value \$750,000*
 - Austria, China, Germany, Japan *Assessed at UN rates





Other costs

- Operating costs of Vienna*, Beijing and Bonn Offices
- Costs of Staff servicing meetings and mandated activities
- Participation in global and space-related
- Activities, conferences, experts meetings organized by UNOOSA
 - 8-12 workshops, training events and other activities
 - Long-term fellowship programmes
 - Technical advisory support
 - Nominal funding Regional Centres for Space Science and Technology Education
- UNISPACE+50
- Maintenance of UN-SPIDER Knowledge Portal
- Special events and outreach activities
- Special publications and promotional materials

Voluntary cash contributions

 - Ad-hoc contributions (both small and high-value)
- Dedicated Funding Agreements
 - Soft or hard-earmarked
 - Funds utilization in line with donor agreement
 - Fixed utilization period
 - Long-term/multiple year funding support
