

A Historical Review— "MUJER PARAGUAYA"




Women in Paraguay took an important role during and after the War of the Triple Alliance, first as Resistance or "Residentas", later as Rebuilders or "Reconstructoras"





• In February 22nd, 1868, the citizens of Asunción was subjected to a very drastic executive order:

"Due to the state of war that our republic is being subjected to and, for the sake of the defense of our liberty and independence, it is mandatory to evacuate the capital city as one of the lead point to be unoccupied."

When evacuation order came, each "Residenta" was assigned to reside to a specific location in Paraguay.

When enemy repression was more violent, residence locations were moved towards north, they eventually reached Cerro Cora and its surroundings.

This is why to all these pilgrims they were called **«Residentas»**, they weren't notified ahead of their destinations, or what they called as their "residence."







- Towards the end of the great war, Paraguay was facing difficult times as skilled men were killed in combat. Only senior citizens, children and women remained on the land.
- It was during that time women in Paraguay took leadership, since all men were sacrificed for the nation, women were forced to leave their homes, abandoning all their belongings to the foreign forces.
- Once war was ended, they were the «Rebuilders» of Paraguay. Each Paraguayan women has to play the role of mother and father; teacher and educator; in addition to this, they were the ones who worked the land, founded schools and asylums; and responsible to reestablish the nations economy.

Ministra quiere lanzar satélite para "control" aeroespacial

La Ministra de Defensa Nacional, María Liz García de Arnold, indicó que el Estado busca lanzar un satélite que permita el control del espacio aéreo nacional. Actualmente nuestro país esta prácticamente "ciego" con respecto a las aeronaves que ingresan al país. El satélite permitiría el control del espacio aéreo, terrestre y fluvial.



Paraguay busca lanzar satélites para control del espacio aéreo nacional

La Ministra indicó que presentó un proyecto para crear una agencia nacional de control aeroespacial como primera medida para impulsar políticas y programas aeroespaciales. "Para iniciar este proceso se debe crear la institución, reglamentar su funcionamiento y establecer los procesos para lanzar un satélite que controle nuestro espacio".

"Los controles del nuestro territorio, abarcan el suelo, agua y el espacio aéreo. Todo ese espacio está sin control. Tomando el aspecto de vigilancia y control del espacio aéreo, se presentó un proyecto para crear una agencia autárquica, con derecho público para desarrollar políticas y programas aéreos espaciales que tiene que ver con la defensa nacional", explicó la Ministra de defensa.

La Ministra de Defensa indicó que una política bien establecida permitirá el control satelital, desarrollo económico y científico. "Los aspectos que vamos a mejorar con esto son la comunicación, vigilancia e información; esa es parte de una iniciativa que conlleva al control de nuestra soberanía".

De no contar con un satélite a corto plazo, el Estado podría alquilar módulos espaciales. "Si nosotros tuviéramos alquilados o comprado el modulo de comunicación, las empresas de telefonía estaría utilizando el modulo comunicacional y no tendría que salir a través de un medio extranjero", ejemplificó García de Arnold en una nota a la 970 AM.

El proyecto contempla el lanzamiento de un satélite en los próximos cinco años, mínimamente. En este proyecto están involucrados el Ministro de Defensa, el Consejo Nacional de Ciencias y Tecnología y las comisión de Ciencia y Tecnología del Congreso Nacional.

 - General Assembly approved resolutions on space.



- •To promote the creation of human recourses in this filed.

These objectives are in tune with the Government's National Plan of Development also known as 2030 Paraguay Vision.

One of the strategic action plan is the "Insertion of Paraguay in the World."

Brief Timeline

2014 March Congress passed the law on the creation of the Paraguayan Space Agency. Law 5151/14.

This agency will be under the administration of the president of Paraguay.

2016 November SE APRUEBA EL TRATADO DEL ESPACIO DE 1967, LEY No. 5740

2016 ecembe Executive order (Act 6466/17) appointed Liduvino Vielman Díaz as its first president. From here, operation of this agency began.

2017 July Executive order (Act 7364/17) established the external advisory board. There are 12 members in total, from public to private institutions.
