Michael Newman works as a Legal Officer with the United Nations Office for Outer Space Affairs (UNOOSA), Committee, Policy and Legal Affairs Section. He holds a Juris Doctor (JD) degree in Law in the United States and a Master of Laws (LL.M) in International Air and Space Law from Leiden University in the Netherlands. He also holds a Master of Business Administration (MBA), and Mr. Newman is licensed to practice law in the United States Jurisdictions of New York and California.



Prof. Olavo Bittencourt is Professor for International Law at the Catholic University of Santos and arbitrator for space related disputes at the Permanent Court of Arbitration. He is Member of the Board of the International Institute of Space Law and serves as Co-vice chair of the Hague International Space Resources Governance Working Group, Delegate at the United Nations Committee on Peaceful Uses of Outer Space, Member of the Editorial Board of the Journal of Air and Space Law, Member of the Brazilian Association of Air and Space Law and the Ibero-American Institute of Aeronautical and Space Law and Commercial Aviation and is recipient of the IISL Diederiks-Verschoor Award.



Ambassador Andrzej Misztal (in diplomatic service of Poland from 1992 to 2022). During his career he served as Director of the Legal and Treaty Department in the Ministry of Foreign Affairs of Poland Legal Adviser to the United Nations and representative of Poland to the 6th Committee of the UNGA. He was also deputy Permanent Representative of Poland to the UN Office in Geneva. He also represented Poland in the International Commission for the International Tracing Service, Senior Arctic Official – representative of Poland to the Arctic Council, Poland being observer. He chaired Polish delegations to the Antarctic Treaty Consultative Meetings. Participated as representative of Poland and head of delegation in many bilateral and multilateral negotiations, including under the auspices of the United Nations, the Council of the European Union (he chaired the working group on sanctions), as well as in the Council of Europe. From 2018 to 2020 he was Chair of the Legal Subcommittee of the UN Committee on the Peaceful Uses of Outer Space (COPUOS). At present he is Chair of the Working Group of the Legal Subcommittee on Legal Aspects of Space Resource Activities (elected in June 2021). He is an independent expert. His areas of interest and professional efforts include disarmament, humanitarian and outer space law.



Steven Freeland (PhD, LLM, LLB, BCom) is Emeritus Professor for International Law at Western Sydney University, where he was previously the Dean of the School of Law, and Professorial Fellow at Bond University. He also holds Visiting or Adjunct positions at various other Universities/Institutes in Copenhagen, Vienna, Toulouse, Hong Kong, Montreal, Kuala Lumpur, Vancouver, Mumbai and London. Prior to becoming an academic, he had a 20-year career as an international commercial lawyer and an investment banker. He is a government-appointed Member of the Australian Space Agency Advisory Board

and has been an advisor to the Australian, New Zealand, Norwegian and several other Governments on issues relating to national space legislative frameworks and policy. He represents the Australian Government at Committee on the Peaceful Uses of Outer Space (UNCOPUOS) meetings and, in June 2021, was appointed by UNCOPUOS as Vice-Chair of a 5-year 'Working Group on Legal Aspects of Space Resource Activities'. He has also been a Visiting Professional within the Appeals Chamber at the International Criminal Court, and a Special Advisor to the Danish Foreign Ministry in matters related to the International Criminal Court. He is a co-Principal of specialised space law firm Azimuth Advisory, a Member of the World Economic Forum (WEF) Global Future Council on the Future of Space, a previous Director of the International Institute of Space Law (2010-2022), a Member of the Advisory Board of the Space Generation Advisory Council (SGAC), a Member of the Space Law Committee of the International Law Association and a previous Member of the Space Law and War Crimes Committees of the International Bar Association. In 2022, he was presented with a 'Lifetime Achievement Award' by the International Institute of Space Law, the highest accolade awarded by that institution. In addition to co-Editing the Annotated Leading Cases of International Criminal Tribunals book series, he also sits on the Editorial Board / Advisory Board of several internationally recognised academic journals.



Gabriel Swiney is the Director of the Policy, Advocacy, and International Division at the U.S. Department of Commerce's Office of Space Commerce. He leads a team representing the United States internationally, designs and implements national space policies, and works to build a U.S. system that promotes the growth of the space sector. Previously, Gabriel Swiney was a Senior Policy Advisor at NASA, where he worked in the Office of Technology, Policy, and Strategy. He advised NASA leadership on a wide range of issues, including implementation of international rules and norms of behavior and global and commercial partnerships. Gabriel Swiney previously served as the lead international space lawyer for the U.S. Department of State, where he also focused on advanced technologies. He advised the United States National Space Council as well as Department of State officials on all issues relating to international space law as well as the nexus between international rules and domestic laws and regulations and served as the U.S. Head of Delegation to the COPUOS Legal Subcommittee. He was one of the primary creators of the Artemis Accords. Gabriel Swiney has been a lecturer at Harvard Law School, where he taught a course on space law and policy. He holds law degrees from Harvard and Oxford law school.



Tare Brisibe is in-house counsel at global satellite operator SES, with responsibility for SES's government policy and regulatory activities in Asia-Pacific. Tare has two decades of aerospace experience in government, intergovernmental organizations and industry. Added to private legal practice with law firms, he previously served as: Chair of the Legal Subcommittee, UN Committee on the Peaceful Uses of Outer Space; and Deputy Director (Legal), National Space Research and Development Agency of Nigeria. He has been a member of the Foreign Service since 1995 and actively participated in the United Nations Working Groups of Governmental Experts on Transparency and Confidence-Building Measures in Outer Space, Governmental Experts on Preventing an Arms Race in Outer Space, Open-ended Working Group on Nuclear Disarmament, Openended Working Group on Lethal Autonomous Weapons, Open-ended Working Group on Reducing Space Threats through Norms, Rules and Principles of Responsible Behaviours (Chair). He served as Chairman of the Legal Subcommittee of the United Nations Commission on Peaceful Uses of Outer Space. He studied Journalism at the University of Chile and joined the Diplomatic Academy in 1995. He also has a degree in International Security and Defence (ANEPE), a master's degree in International Law and International Relations from the Ortega y Gasset Institute (Madrid) and a Master's degree in International Law on Armed Conflict from the Institute of Advanced International Studies and Development (Graduate Institute) in Geneva. He has served in the Embassies of Chile in Jamaica, Italy and Austria. He has also been Alternate Permanent Representative to the United Nations in Vienna and Alternate Permanent Representative to the Conference on Disarmament in Geneva.

Communications Commission and also leads the FCC's Privacy and
Data Protection Task Force. He previously served as Deputy Chief in
the Foreign Investment Review Section of the U.S. Department of
Justice's National Security Division where he oversaw DOJ's
interagency role as Chair of the Committee for the Assessment of
Foreign Participation in the United States Telecommunications
Services Sector (informally known as Team Telecom). Mr. Egal was a
federal prosecutor in the U.S. Attorney's Offices for the Southern
District of New York and the District of Columbia and clerked for U.S.
District Judge Alia Moses. He received his undergraduate degree from
St. John's University and his law degree at the Howard University
School of Law.



Prof. Yun Zhao is Henry Cheng Professor in International Law and Associate Dean (Mainland Affairs), Faculty of Law at the University of Hong Kong (HKU). Prof. Zhao is currently Representative of Regional Office for Asia and the Pacific (ROAP) of the Hague Conference on Private International Law (HCCH); Standing Council Member of Chinese Society of International Law, Chinese Society of Private International Law and Chinese Institute of Space Law; Council Member of Chinese Law Society. He is listed as arbitrator in several international arbitration commissions. He has published widely on various topics including particularly Space Law, Dispute Resolution, and E-commerce Law.



Vasily Gudenov is Head of Multilateral Cooperation Division of the International Cooperation Department, The State Space Corporation (ROSCOSMOS.) Dr. Gerardine Goh Escolar is Adjunct Professor at the Faculty of Law, National University of Singapore. Concurrently, she is Deputy Secretary General of the Hague Conference on Private International Law (HCCH), an international intergovernmental organization, where she also heads two Divisions: the International Commercial, Digital and Financial Law Division, and the Transnational Litigation Division. Her work focuses on the international legal, economic and policy issues relating to emerging technology (blockchain and crypto, web3, fintech, communications, aerospace and outer space), inter-State and transnational dispute settlement, environmental protection and sustainability, and venture building.



Prof. Sergio Marchisio is Professor for Space Law, Sapienza University of Rome and serves as Vice-President of the Italian Society for International Organization (SIOI). He is Chairman of European Centre for Space Law (ECSL/ESA). General Counsel of the International Astronautical Federation (IAF) and served as Senior Legal Advisor of Italian Space Agency (ASI) and former Member of its Board of Directors (2014-2018). He served as Italian Delegate to UNCOPUOS since 1997 and as Chairman of the Legal Subcommittee (2004-2006) and Co-chair of the Expert Group D (Regulatory Regimes and Guidance for Actors in the Space Arena) of the Working Group on

Long-Term Sustainability of the Outer Space Activities (2010-2018). Since 2007, he is Italian Delegate to the Council of the EU for the Negotiation of the International Code of Conduct on Outer Space Activities (ICoC), Chair of the multilateral negotiations held at the United Nations (New York, 2015), since 2010, UNIDROIT correspondent for Italy, Chair of the Committee of Governmental Experts for the preparation of a Protocol to the Cape Town Convention on Matters specific to Space Assets (2003-2012) and of the Committee of the Whole of the 2012 Berlin Diplomatic Conference, which adopted the Protocol. He was Member of the UN Groups of Governmental Experts on Outer Space Transparency and Confidence-Building Measures (TCBMs, 2011-2013), and on Practical Measures for the Prevention of an Arms Race in Outer Space (PAROS, 2018-2019), Member of the Specialized Panel of Permanent Court of Arbitration pursuant to Optional Rules on Disputes relating to Outer Space Activities. In 2011, he received the Social Sciences Award from the International Academy of Astronautics (IAA) and, in 2015, the Distinguished Service Award from the International Institute of Space Law (IISL). He is author of over 250 scientific publications, including the volume "The Law of Outer Space Activities" (2022).



Rosanna Hoffmann is currently serving as Programme Officer for the "Space Law for New Space Actors" project within the Committee, Policy and Legal Affairs Section of the UN Office for Outer Space Affairs within. Prior to joining UNOOSA, she was the Executive Officer of the European Centre for Space Law and worked as a Junior Legal Officer in the Public International Law Division of the European Space Agency, focusing on space law and policy. Before joining ESA, Rosanna worked at the Section for International Law and International Relations within the Department of European, International and Comparative Law at the University of Vienna as an assistant lecturer and project assistant. She has several years of work experience in the Austrian Federal Ministry of Justice, with prime focus of labour law within the penal system. Within the Ministry, she also served as Deputy Head of the Division for Interpreters and Experts.



Niklas Hedman is Vice-Chair of the Committee on Space Research (COSPAR) Panel on Planetary Protection. From March 2022 until September 2023, he was designated Acting Director of the United Nations Office for Outer Space Affairs (UNOOSA).
