SUMMARY OF SCHEDULED MEETINGS

582nd meeting

Opening of the session [1]

The session was opened at its 582^{nd} meeting.

Adoption of the agenda [2]

The provisional agenda (A/AC.105/L.270) was adopted.

Election of officers [3]

Mr. Ciro Arévalo-Yepes of Colombia was elected Chairman of the Committee and Messrs Suvit Vibulsresth of Thailand and Filipe Duarte Santos of Portugal were elected First Vice-Chairman and Second Vice-Chairman/Rapporteur, respectively.

Organization of work

The Committee decided to invite the representatives of Angola, Costa Rica, Côte d'Ivoire, Dominican Republic, the Former Yugoslav Republic of Macedonia, Guatemala, Paraguay, Republic of Yemen, Tunisia, and the Holy See, and to participate in the session as observers.

The Committee also decided to invite the representatives of the European Commission, the European Organisation for Astronomical Research in the Southern Hemisphere (ESO), the European Telecommunications Satellite Organization (EUTELSAT-IGO), and the International Institute of Space Law (IISL) to participate in the session as observers.

Statement by the Chairman [4]

The Chairman made a statement outlining the work of the Committee.

The Committee began its consideration of this item with statements by the representatives of Japan, the Republic of Korea, Belgium, China, Thailand, Colombia, and Chile.
