The Working Group on the Use of Nuclear Power Sources in Outer Space of the Scientific and Technical Subcommittee held an intersessional meeting in the afternoon.

Symposium on Space and Forests

A symposium on "Space and Forests" was held following the adjournment of the 557th meeting of the Committee on the Peaceful Uses of Outer Space, in Conference Room III.

The symposium was moderated by Mr. L. Beckel of Austria. Presentations were made by Ms. A. Branthomme of the Food and Agriculture Organization of the United Nations (FAO) on "Global forest monitoring", by Mr. A. Belward of the European Commission on "Global TREES Project: using space applications for monitoring forests", by Mr. E. Csató of Hungary on "Applications of remote sensing data in forestry", by Mr. A. Salami of Nigeria on "Space technology for monitoring and managing forests in Nigeria", and by Mr. J. Wichawutipong of Thailand on "Forest area monitoring in Thailand with the use of satellite imagery".

A discussion session to identify ways in which developing countries can make use of space-based data and information to protect their forests, and to recommend ways of expanding the use, in developing countries, of space-based data and information for forest management took place following the presentations.
