Status and application of the five United Nations treaties on outer space [6]

The Subcommittee concluded its consideration of this item with the adoption of the report of the Working Group on the Status and Application of the Five United Nations Treaties on Outer Space (A/AC.105/C.2/2006/TRE/L.1).

Matters relating to:

- a) The definition and delimitation of outer space;
- b) The character and utilization of the geostationary orbit, including consideration of ways and means to ensure the rational and equitable use of the geostationary orbit without prejudice to the role of the International Telecommunication Union [8]

The Subcommittee concluded its consideration of this item with the adoption of the report of the Working Group on the definition and delimitation of outer space (A/AC.105/C.2/2006/DEF/L.1).
