A non-paper on "Preliminary plans for the celebration of the fiftieth anniversary of the Space Age in 2007" was presented by the incoming Chairman of the Committee on the Peaceful Uses of Outer Space. Statements were made by the representatives of Chile, Greece, Ecuador, Colombia, India, Nigeria, Brazil, Canada, Kazakhstan, Libyan Arab Jamahiriya, Austria and Russian Federation.
