

Benefits of becoming a Party to the U.N. Treaties on Outer Space

- Participate in established and recognized legal framework
- Access to a space-specific liability regime —Negligence in space
 - -Strict liability on Earth and to aircraft in flight
 - -Victim-oriented system
- Access to peaceful dispute mechanisms and compensation for damage



Benefits of becoming a Party to the U.N. Treaties on Outer Space

- Increased probability of engaging in space technology commerce
 - -China's ratification of the Outer Space Treaty and Liability Convention made it eligible to launch U.S. commercial satellites
- Can catalyze national space law —Protects and promotes National interests



Benefits of Becoming a Party to the U.N. Treaties on Outer Space

- Join a community of approximately 100 Nation-States
 - -Spacefarers
 - -Nonspacefarers
- Increased opportunities to engage in cooperative and related scientific and educational activities, data, and information
- Ability to participate in future international space law making

Benefits of Becoming a Party to the U.N. Treaties on Outer Space

- Codifies "political will" of a State to play by the global rules
 - —Stabilizes relationships to, and future partnerships with, 100+ or so Nation-States with respect to outer space activities
- Increased international peace and security

 –via increased security for space based assets
 for those countries that have them
 - —and via space based services for the countries that rely on them; in particular non-spacefarers
