INTRODUCTION

The international space law treaties were drafted at a time, when States were the main actors and the development of a commercial market for transfer of space objects and control of space objects could not been foreseen. Therefore, the existing treaties do not contain any provisions relating specifically to transfer of ownership of a space object and the responsibilities that this entails leading to a legal vacuum. The registration procedures of States and international organizations with regard to space objects vary widely from one national jurisdiction to another. To prevent the emergence of a "flag of convenience" phenomenon in space and to provide legal certainty with respect of issues concerning responsibility and liability, a sound and well-tailored legal framework has to be put in place. Against this backdrop, the space community faces now the legal challenge to regulate the effects arising from the transfer of ownership of space objects. This year's edition of the IISL-ECSL Symposium intends to provide a new impetus to the international debate by encouraging a dialogue between leading academicians and distinguished stakeholders.
