The meeting was called to order at 20 a.m.

**The CHAIRMAN**: Good morning distinguished delegates, I now declare open the  $782^{nd}$  meeting of the Legal Subcommittee of the Committee on the Peaceful Uses of Outer Space.

I would first like to inform you of our programme of work for this morning. We will continue with the adoption of the report of the Legal Subcommittee.

Are there any questions or comments on this proposed schedule?

# Adoption of the report of the Legal Subcommittee on the Peaceful Uses of Outer Space

Now we will consider Addendum.2 and 3. Yesterday we adopted the first and second part of the draft report which is contained in document A/AC.105/C.2/L.273 and Addendum.1, including some amendments, of course.

Today I would like to continue this adoption of the third and fourth parts of the report which is contained in Addendum.2 and 3.

We will start with Addendum.2 which contains sections on matters relating to the definition and delimitation of outer space and the character and

utilization of the geostationary orbit, including consideration of ways and means to ensure the rational equitable use of the geostationary orbit, without prejudice to the role of the International Telecommunication Union. This is one section or one part of Addendum.2. And the second one is on capacity-building in space law.

Do all delegations have the document we will begin considering before them?

Again, this document is A/AC.105/C.2/L.273/Add.2.

We will now proceed with paragraph-by-paragraph adoption of the Addendum.2.

I have an application for the discussion from the distinguished delegation of Nigeria.

\_(?) (Nigeria): Thank you Mr. Chairman. I am sorry but at the risk of putting us back to some parts of the report that we adopted yesterday. I noticed the need for a minor editorial amendment in one of the documents, L.273/Add.1. in Part 4 of that document which relates to information on the activities of international intergovernmental and non-governmental organizations relating to space law. In paragraph 20 where activities of all the international intergovernmental organizations were reported, I would, in addition, like to ask for redrafting of paragraph(?) 20 so that it will have the same reporting style with subsequent paragraphs 21, 22 and so forth. What I intend to submit for the consideration, Mr. Chairman, is that the activities of IAA in spacerelated activities, relating to space law, should be a

little bit elaborated so that we can understand and keep track of what they are doing.

The Secretariat will prepare the text of such an enlarged wording of this particular paragraph and I will inform the Subcommittee about it at a later stage. Thank you very much and thank you for your patience.

We will now proceed, as I already suggested, with Addendum.2.

The CHAIRMAN: Thank you distinguished esentative of Nigeria for your contribution by ch you draw on our attention to the question of who ald be responsible for such initiatives or such sures that have been listed here in individual subgraphs. Of course, I should draw your attention the chapeau does not speak about it and does not a target of identifying who should be responsible. only a list of actions that might strengthen the acity-building in space law but, in any case, I will the floor to our Secretary first to explain in some greater detail the formulation of the sub-paragraphs.

Ms. N. RODRIGUES (Deputy Secretary, Office for Outer Space Affairs): Thank you Mr. Chairman. The distinguished delegate of Nigeria is, in fact, correct. We have left the paragraph broad quite purposely because some of the elements, I think, that can only be done by national institutions, things like introducing space law courses into the international course, that clearly. But there are a number of things and I know delegations did propose that a number of these things be some that the Secretariat of the Office for Outer Space Affairs to take care. situation is that the Office for Outer Space Affairs itself is not in the position to commit to anything yet because we really have to go back, look at our human resources and possibly the financial situation and identify the things that we can address. I can give you an example, the updating of the publication. That would be something that the Office for Outer Space Affairs would have to do, whether we can do it in a space of a year or a space of two years is something we have to go back and evaluate. But I do not see a great big problem with that apart from the time and human resources factors and a number of things.

This is the only explanation I can give you. If you would like, we could, the Secretariat is intending to look at capacity-building in a much broader context in terms of organization within the Office and we do hope to come back at some point and identify where we can actually contribute to capacity-building and which elements we cannot do without, either additional human resources or financial or expertise because there are some elements where we need the expertise to come from our member States or from institutions.

So this is the reason why the list was left broad. We thought that all the suggestions were quite useful so we decided to include them so that it is on record and I leave it to delegations to give a start on how you would wish to reflect this in the report, if necessary.

**The CHAIRMAN**: Thank you distinguished Deputy Secretary for your answer to this question that has been raised and to this initiative on the part of the distinguished representative of Nigeria.

Would it be satisfactory this explanation for the delegation of Nigeria?

Mr. (Nigeria): Thank you Mr. Chairman, for the time being, probably during the intersessional appears(?) there could be some kind of contacts and meetings online whatever that would make delegations to come up ideas as to

how to ensure the implementation of these actionoriented activities, as my delegation, and I believe many developing countries, would like to see concrete action plans concerning what this Subcommittee is going to do concerning this agenda item. Thank you Sir.

The CHAIRMAN: Thank you distinguished representative of Nigeria. I also believe in what has been said by our Deputy Secretary that even this listing of the areas in which we may develop a further effort is a certain result because it is an extensive list including many, many different trends and orientations that might be and should be, of course, fulfilled. And since the item, capacity-building, remains on the agenda of the Subcommittee for the next year and maybe even beyond, I do not know, we can, during the next session, elaborate in some greater detail the implementation of these individual sub-paragraphs and change them in specific actions.

Yes, would it be satisfactory for the time being? Yes. Thank you for your cooperation distinguished representative of Nigeria.

So, with this comment, is there any other comment on this particular paragraph?

Yes, the distinguished representative of Ukraine has the floor.

Now, and if you permit, I will read this new item.

**The CHAIRMAN**: ... distinguished representative of Ukraine, does it relate to the text of paragraph 45 or is it a new paragraph dealing with another matter?

Mr. \_\_\_\_\_\_(?) (Ukraine): No, this new item concerns to the whole of Part VIII.

**The CHAIRMAN**: The whole of Part VIII? So would you be so kind as to wait a little bit because we will have to finish paragraph 45. And then, of

course, I will give you the floor for your proposal. Yes?

Thank you for your cooperation and I have still the distinguished delegation of France on my list of speakers.

Ms. \_\_\_\_\_\_\_(?) (France) (interpretation from French): Yes, thank you Mr. Chairman. Given the statements made on this paragraph 45, particularly the Secretariat's explanation, the French delegation has a question. Would it be possible to add at the end of paragraph 45 that "it was agreed that the Secretariat could identify areas for capacity-building". A neutral wording which would reflect the explanation provided by the Secretariat.

The CHAIRMAN (interpretation from French): Thank you very much distinguished representative of France. Could you repeat the text which you propose as an addition to the text of paragraph 45? It would be an addition at the end after sub-paragraph (1) "it was agreed that the Secretariat might identify capacity-building potential in the area". Thank you.

Maybe we should now ask the Secretariat to read the text that they have prepared which would incorporate your suggestion but also some of the other suggestions submitted earlier. So, with your permission, I am going to ask the Deputy Secretary of the Subcommittee to read the text.

**Ms. N. RODRIGUES** (Deputy Secretary, Office for Outer Space Affairs): Thank you Mr. Chairman. Well, I hope the Secretariat has come up with something that is in the spirit of the proposals we have heard.

Perhaps as a paragraph 45 bis we could say "the Subcommittee recommended that member States, the Permanent Observers of the Committee, as well as the Office for Outer Space Affairs, should consider the implementation of the above-mentioned and to inform the Subcommittee at its forty-eighth session on any actions taken or planned."

**The CHAIRMAN**: Distinguished Deputy Secretary, would you repeat it once again and subsequently the last part of this paragraph because it was not quite clear to me what you really expect. So once again at dictation speed, yes.

**Ms. N. RODRIGUES** (Deputy Secretary, Office for Outer Space Affairs): "The Subcommittee recommended that member States, the Permanent

Observers of the Committee, as well as the Office for Outer Space Affairs, should consider the implementation of the above-mentioned list and to inform the Subcommittee at its forty-eighth session on any actions taken or planned" and perhaps I can add "on a national, regional or international level".

Would you like me to repeat once more?

**The CHAIRMAN**: It is up to the delegations. Do you want still this proposal be repeated once more?

I see no such request so let us proceed further.

Does this formulation suggested by our Deputy Secretary satisfy all delegations, particularly those who proposed their own ideas about it?

I see no objection.

It is so adopted.

And it will be, in my understanding, a new paragraph. Yes? Following Article (paragraph?) 45.

So first, we should approve paragraph 45 as a whole because we have not done it yet. So paragraph 45, as it says.

Is there any comment on it? And, of course, it was approved provided that a new paragraph would be added as paragraph 46 (paragraph 45 bis?) and the text of which was read by the Deputy Secretary and approved by yourself.

It is so decided.

And we still have the last paragraph, it is the present paragraph (l). Sorry, I forgot that agreed to give the floor to the distinguished representative of Ukraine. You have the floor Sir, concerning this part of the report as a whole, yes? This was my understanding.

And now, with your permission, I will read the text of this new item.

"The Subcommittee was informed about the planned International Conference on Capacity-Building in Space Law which would be held in Kiev, Ukraine, June 2008 on the occasion of the tenth anniversary of the Ukrainian and Russian Agreement on the foundation of the International Centre for Space Law. The delegation of Ukraine invited all interested delegates to take part in this conference." Thank you.

**The CHAIRMAN**: Thank you. Would you repeat this text at dictation speed?

**The CHAIRMAN**: Thank you very much distinguished representative of Ukraine. I have only two minor comments before I give the floor to the delegations.

First of all, where it should be included, where exactly? Yes, I know, this was suggested but is it the proper place for it because it might be included before? I do not know.

The Deputy Secretary just advised me that the Secretariat would check whether it should be included, as you suggested, in this place, it means after paragraph 45 and 46 now or whether it should be included earlier. This would need some reflection and we would lose much time by it but it will be included in this section of the report. Would you agree to such powers of the Secretariat to do so? Yes, I appreciate your cooperation.

And my second remark is you said that this conference which, without doubt, is very important and appropriate, should be held in June 2008, yes, is it so? Yes, but have you taken into account that in June there is the session of the main Committee that it might hinder some delegates which regularly participate in the work of the COPUOS, of the main Committee, to come and participate in the conference that you intend to organize. Do you have any idea which exact dates you have in mind?

Mr. \_\_\_\_\_(?) (Ukraine): Thank you Mr. Chairman. Of course, we will take into

consideration this information and we will define the date of the conference later.

**The CHAIRMAN**: Perhaps during the second half of the month of June but it is up to you to decide on this question, of course. Thank you very much.

Is there any comments on this proposal made by our distinguished colleague from Ukraine?

I see none.

It is so decided.

Including the decision that it would be checked by the Secretariat whether this is the proper place or it should be included earlier in this part of the report.

Ladies and gentlemen, we now have the last paragraph of this part of the report, the present paragraph 46. This is a routine paragraph. I think there is no objection against it and in this way, this part of our report is adopted.

We will now proceed with discussion on Addendum.3. I will repeat that it is document A/AC.105/C.2/L.273/Add.3. And since this part of the report was distributed only in the beginning of this meeting so I will give you perhaps more time in order to check whether all these texts reflect your positions expressed during the session of the Subcommittee.

**The CHAIRMAN**: Yes, would you be so kind as to repeat it once again at dictation speed.

**The CHAIRMAN**: Thank you very much distinguished representative of the United Kingdom for your comments and also for your providing us with a text of paragraph 24 as you wish to be amended.

Yes, the Secretary of the Subcommittee has just drawn my attention to the right title of the item and of the document of the Chairman that you requested to be checked and it is "future role and activities of the Committee". Thank you very much.

Are there any other views on the formulation of paragraph 24?

I see none.

I take it that it was adopted by consensus and it is so decided.

Paragraph 25.

Any comments on this particular draft paragraph?

No comments.

Adopted.

Paragraph 26.

Any comments?

No comments.

Adopted.

As the view, it means the view of one delegation which, however, is not present, yes.

Paragraph 27.

Any comments on paragraph 27?

No comments.

Adopted.

Paragraph 28.

Any comments on draft paragraph 28?

I see none.

It is adopted.

Paragraph 29.

The view of some delegations.

No comments.

Adopted.

Paragraph 30.

Again, it is a longer paragraph consisting of a chapeau and of six sub-paragraphs (a) to (f). So let us proceed slowly.

First, the chapeau.

This is the usual chapeau that was used in our previous reports.

Now sub-paragraph (a).

Greece is not here but I have not heard any comment from it from the distinguished representative of Greece before his departure.

Sub-paragraph (b).

Neither did I hear any comments from the part of the Czech delegation and from the Greek delegation.

Sub-paragraph (c).

Sub-paragraph (d).

Again Greece.

Sub-paragraph (e).

China, Greece, the Russian Federation and Ukraine.

Sub-paragraph (f).

Proposed by Chile.

Any comments to the paragraph as a whole? It means paragraph 30 including six sub-paragraphs.

No comments.

It is adopted.

Paragraph 31.

A routine sentence.

No problems.

Adopted.

Ladies and gentlemen, we have just concluded the observation of all these addenda, of the document and all its addenda, but we have two outstanding paragraphs that should be still taken into account because we said we would provide, the Secretariat would provide an exact text of these two particular paragraphs. And I think the first one related to the proposal made by our distinguished colleague from Ecuador and the other one that was requested by our distinguished colleague from Nigeria and because our Secretariat has been thirsty(?) to prepare the text so I will give now the floor to the Secretary or to the Deputy Secretary. Yes, the Secretary.

Mr. N. HEDMAN (Secretary, Office for Outer Space Affairs): Thank you Mr. Chairman. Yes, the Secretariat will now read out a proposed paragraph by the delegation of Ecuador to be included in the section on general exchange of views and I refer to document L.273, the first document that we considered yesterday, document L.273, general exchange of views, last page, Page 6.

The paragraph would be included as a paragraph 27 *bis* on Page 6 of document L.273 and the proposed text reads as follows.

"The Subcommittee noted that the Pro Tempore Secretariat of the Fifth Space Conference of the Americas had held consultations with members of the International Group of Experts during the 2008 International Air and Space Fair and had decided to convene a second meeting of the International Group of Experts in conjunction with a Seminar on Space Law for Development and Human Security to be held in Ecuador on 24 and 25 July 2008."

Thank you Mr. Chairman.

The CHAIRMAN: Thank you Mr. Secretary for your providing us with the exact text of a new

paragraph 27 bis in accordance with the proposal made yesterday by our distinguished colleague from Ecuador.

Is anybody in agreement with this text? Does it satisfy the delegation of Ecuador? I see yes.

Any other comments?

No comments.

It is adopted. As paragraph 27 bis.

And the second proposal will be made by the Deputy Secretary.

Ms. N. RODRIGUES (Deputy Secretary, Office for Outer Space Affairs): Thank you Mr. Chairman. The second outstanding paragraph is relating paragraph 20 of L.273/Add.1. It is a proposal that was made this morning by the distinguished delegate of Nigeria to supplement information contained in that paragraph. The Secretariat would like to suggest the following.

So at the end of the existing paragraph 20, we would add the following additional sentences. I will read it first quickly and then more slowly at dictation speed.

"The Subcommittee noted that in 2007 the IAA had organized the First Regional Conference in Africa on the Path to Knowledge and Development, in Abuja, from 3 to 5 December 2007. The Conference allowed the engagement of the IAA's members and promoted interaction with countries that are not significantly participating in such international meetings. The Subcommittee noted with satisfaction that the IAA had, as a result, decided to annually organize such a conference in Africa."

I will now repeat it at dictation speed. So following the last sentence of the paragraph 20, we would have the following new sentence.

"The Subcommittee noted that in 2007 the IAA had organized the First Regional Conference in Africa on the Path to Knowledge and Development, in Abuja, from 3 to 5 December 2007. The Conference allowed the engagement of the IAA's members and promoted interaction with countries that are not significantly participating in such international meetings. The Subcommittee noted with satisfaction that the IAA had, as a result, decided to annually organize such a conference in Africa."

**The CHAIRMAN**: Thank you Ms. Deputy Secretary for your reading the text of an addition to paragraph 20, according to the proposal of the distinguished representative of Nigeria.

Is the text satisfactory for the distinguished representative of Nigeria? Thank you for your cooperation.

Any other view on this addition to paragraph 20?

So paragraph 20, including this new last part of paragraph 20, has been adopted.

Thank you very much.

Distinguished delegates, we are approaching the final part of our meeting this morning. We have now adopted all parts of the report of the Legal Subcommittee to the Committee on the Peaceful Uses of Outer Space.

Can I take it that the Subcommittee adopts the entire report, as amended, as completed and amended?

I see no objections.

So the report of the forty-seventh session of the Legal Subcommittee, as amended and completed, is now adopted.

It is so decided.

Distinguished delegates, may I now to make the final remarks from the Chair. I will be very brief because I believe that this session has been very effective. We have dealing with all items of our agenda. We have been doing so very efficiently and I also may say briefly and all substantive aspects of the items included in our agenda have been, I think, in fact, thoroughly discussed.

I would like to express my full satisfaction and gratitude to the interpreters in the booth which have effectively helped us in dealing with these issues in a way that I have just described.

I would also like to appreciate perfect work done by the Secretariat of the Subcommittee. Our gratitude to the Office of the United Nations for Outer Space Affairs, led so ably by the Director, Dr. Mazlan Othman, and, of course, particularly those members of the Office which have been engaged in our session here. Again, I would like to mention particularly the Secretary of our Subcommittee and the Deputy

Secretary of our Subcommittee and all other staff members.

I promised to you tentatively yesterday that we would terminate our discussions at 12.00 p.m., at noon today, and we have still now two minutes left. So I believe that it is enough for my declaration on this session, that it is now closed, it means our 782<sup>nd</sup> meeting is closed and also the whole forty-seventh session of the Legal Subcommittee of the Committee on the Peaceful Uses of Outer Space.

I thank all delegations for really excellent cooperation that I felt, as you say, in the task of Chairman of this Subcommittee and I am looking forward to most of you, I hope so, during the consideration of the report of the Legal Subcommittee which is, of course, one of the items on the agenda of the main Committee to be held in June and next year, if everything goes well. We will see each other again here at the next session of the Legal Subcommittee.

Thank you very much and the meeting is concluded.
