

Introduction

This document contains a questionnaire according to which member States are invited to provide information in which concrete ways and manners respective nonlegally binding United Nations instruments on outer space have been implemented. This document would serve as a basis for member States of the Committee as well as international intergovernmental organizations, as appropriate, to provide information related to non-legally binding United Nations instruments. Based on the intersessional informal exchange of views with several member States of the Committee since the 2014 session of the Legal Subcommittee, the list of non-legally binding United Nations instruments to be considered for the discussion under this agenda item has been streamlined for the purpose of a more efficient and effective discussion which will eventually produce useful results. In streamlining the list, our delegation especially aimed at avoiding the possible duplication of the subjectmatters to be discussed and selecting more relevant subjects in accordance with the current status of peaceful exploration and use of outer space. As a result we focused on the non-legally binding United Nations instruments as shown in the following template of the questionnaire.

- (4) Resolution 1721 B (XVI) of 20 December 1961 ((registration of launchings) International Cooperation in the peaceful uses of outer space)
- (5) Other non-legally binding instruments on outer space
