

General exchange of views [3]

The Subcommittee continued its consideration of this item with a statement by the representatives of France and Greece.

Statements were made by the Russian Federation, Ukraine, and the United States in the exercise of the right of reply.

The observer for the European Union also made a statement.

The observers for the Hague Institute for Global Justice, the Moon Village Association (MVA), the Open Lunar Foundation, and UNISEC-Global also made statements.

Future role and method of work of the Committee [9]

The Subcommittee concluded its consideration of this item with statements by the representatives of Ghana on behalf of the African Group, Canada, Chile, Indonesia, the Russian Federation, Ukraine, and the United Kingdom.
