Adjustments to the organization of work

Process to formalize the organization of work

 - → circulation of the result (min. 2 working days to process)

Decision/Announcement at the opening meeting



Statements

- Plenary statements: limited to three (3) minutes.
- Statements for interpretation: to be provided at least 2 working days before delivery
 - File names to follow the format: **Agendaltem_CountryName** (e.g. 3_Austria.doc).
 - Top of statement: Country name and Agenda Item (e.g. Austria, Item 3)
- Indicate if the statement should not be uploaded to the website.
- Delivery of pre-recorded statements: See session website for Technical Requirements for pre-recorded

- Member States to speak first under an agenda item; to be followed by observer organizations

The Space2030 Agenda: Space as a driver of sustainable development: UNGA resolution 76/3 of 25 Oct 2021

- COPUOS recalled at its 67th session in 2024 that in 2025 a midterm review of progress made in implementing the "Space2030" Agenda would be conducted at its 68th session, in 2025 and that Member States and observer organizations with the Committee would be invited to submit reports on their key activities in implementing the "Space2030" Agenda (A/79/20, para. 369)
- UN Member States and permanent observer organizations with COPUOS are invited to submit their reports on key activities in implementing the Space2030 Agenda to <u>unoosa-submissions@un.org</u> (ref. OOSA/2024/66, CU 2024/410/OOSA/CPLA)
- Submissions are being made available on the dedicated Space2030 Agenda webpage at unooosa.org, and can provide an important global overview of the space solutions and existing national challenges that could be addressed through access to space data, services and technology.
- The final review of the Space2030 Agenda: space as a driver of sustainable development is envisioned in 2030 and reported to the General Assembly (<u>A/RES/76/3</u>, para. 30)

Liquidity crisis mitigation measures (Part 2)

- Timely issuance of parliamentary documentation in the mandated languages to be significantly impacted.
 - ✓ Agreed schedules and word counts to be strictly enforced.
- In-session documentation to be handled within working hours.
- All departments to <u>reduce</u> the length of their regular reports <u>by 10%</u>.
- Submissions by Member States are handled on as available basis and potentially issued in the language and format received.
- Meetings are <u>fully paperless</u>. Meeting-related parliamentary documentation is made available electronically.
