Working Group on the "Space2030" Agenda

- As per GA resolution 73/6 of 28 October 2018, the Committee has been invited by the GA to *continue to develop, on the basis of the results of the* UNISPACE+50 process, a "Space2030" agenda and implementation plan and to provide the GA with the outcome of its work for consideration by the Assembly at its 75th
- The GA plenary item on "Space2030" Agenda is scheduled for 26 October 2020
- As per its workplan for 2020, the Working Group was scheduled to meet during the sessions of the STSC, LSC and COPUOS
- In view of cancellation of the LSC and COPUOS sessions and WG meetings, the meeting of the Working Group is scheduled to take place from 26 to 28 August, in BR-D, with interpretation and a possibility of a hybrid meeting
- The Working Group will have before it document A/AC.105/C.2/L.316 Revised draft "Space2030" agenda and implementation plan, issued on 21 February 2020, in all official UN languages
