European Interparliamentary Space Conference (EISC) is a unique formal framework for engagement and coordination between national legislators in Europe focusing on space.



Established in 1999.



Permanent forum for inter-parliamentary co-operation between the European national parliaments interested in space policy.



Rotating Presidency.



Aims:

- Provide a platform for analysis of major issues at stake in the European space sector.
- Facilitate exchange of information on space activities.
- Promote mutual understanding of national policies.

Legislating Space: Key Takeaways from the EISC Workshop

Space Legislation as a Citizen's Affair

Commercial actors catalyse the need for an evolved regulation of space activities; however, such legislation requires a holistic approach. Expanding the focus beyond the commercial dimension of space also enables the futureproofing of international and regulatory frameworks.



Space for Security & Defence Increasingly Paramount for European Legislators

Use and regulation of space assets and space activities for security and defence applications are increasingly top of mind for legislators. Parliaments are encouraged to take new actions in the scope of their competences and play a conducive role in development of the security and defence dimension of space in Europe.

The Continuing Evolution of European Space Legislative Landscape

The anticipated EU Space Law: expected to facilitate a move from a patchwork of national regulatory environments to a consolidated EU-wide framework.

EU Member States face uncertainty about the effects of the EU Space Law in the context of their national laws and regulatory frameworks.

Recalling the Importance & Necessity of Multilateralism

There is common interest among European legislators to nurture the exploration and use of outer space through multilateral cooperation. While the influence of parliaments on international regulation and coordination is limited, this interest reaffirms the importance of parliamentary diplomacy, including through frameworks such as EISC.
