Project Introduction:

Fostering responsible national space activities

- Space activities support economic growth, deliver high returns on investment, generate new technologies and create jobs.
- Record numbers of countries and nongovernmental entities are investing in the space environment.
- Awareness of, and adherence to, international space law is becoming more important than ever.

- Promote awareness of legal and policy aspects
- Draw attention of authorities and decision-makers to topical issues
- Promote implementation of the legal regime of outer space
- Enhance capacity-building efforts





Background

UNOOSA is receiving regular requests for targeted technical legal assistance to support in the development of national space policy and legislation as well as implementation of 5 UN Space Treaties, principles and guidelines.

The importance of UNOOSA delivering such services has been recognised on multiple occasions, including:

- Declaration on the fiftieth anniversary of the Treaty on Principles Governing the Activities of States in the Exploration and Use of Outer Space, including the Moon and Other Celestial Bodies (A/RES/72/78) December 2017
- Report on the United Nations/Austria Symposium on the theme "Access to space: holistic capacity-building for the twenty-first century" (A/AC.106/1162) Graz, 3-7 September 2017
- Report on the United Nations Workshop on Space Law (A/AC.105/1131) Vienna, 5-8 September 2016
- Report of Legal Subcommittee (2017, 2018)

Legal Advisory Project on Space Law for New Space Actors Fostering responsible national space activities

- Presented at Legal Subcommittee (April2019) and UN/Austria Symposium (September 2019)





Project Objectives

The project will allow UNOOSA to establish dedicated advisory services to assist emerging space faring nations on national space legislation and national space policy.

The project aims to:

- In collaboration with requesting States, identify needs and deliver tailored advisory services.
- Raise global awareness levels of the fundamental principles of international space law.
- Support the universalization, adherence and implementation of the key components of normative framework.





Key Areas to be Focused

- Responsibility of States for governmental and nongovernmental space activities
- Liability for damage caused by space objects
- Duty to provide information on and to register space objects
- Debris mitigation
- 21 LTS Guidelines

Services on offer

- UNOOSA to support partners enhance understanding of the fundamentals of international space law, increasing their capacity to draft or revise national space law and policy.
- UNOOSA supports partners implement existing normative frameworks, such as the Outer Space Treaty, the Liability Convention, the Registration Convention and the UN Space Debris Mitigation Guidelines.

Stage 3) On-site legal advisory services

Stage 4) Impact evaluation






Target Beneficiaries
