**Information on consultative status with the Economic  
and Social Council (ECOSOC) of non-governmental  
organizations having permanent observer status with  
the Committee**

**Note by the Secretariat**

At its fifty-sixth session, in 2013, the Committee on the Peaceful Uses of Outer Space requested the Secretariat to present to it, on an annual basis, information on the consultative status with ECOSOC of non-governmental organizations having permanent observer status with the Committee (see para. 345 of the report of the Committee in A/68/20).

Following that request, the Office for Outer Space Affairs of the Secretariat compiled a table, highlighting the status of the above-mentioned organizations vis-à-vis ECOSOC. The table was compiled on the basis of information derived from the database contained on the website of the United Nations Department of Economic and Social Affairs (UNDESA), NGO Branch <http://esango.un.org>. The table was made available by the Office in its note verbale OOSA/2014/6, CU 2014/87, sent on 22 April 2014 to relevant permanent observers of the Committee, for their review and clarifications.

The present conference room paper contains the updated information on consultative status with the Economic and Social Council (ECOSOC) of non-governmental organizations having permanent observer status with the Committee, as indicated by the database of the NGO Branch of UNDESA.
