## Introduction

The increasing number of States involved in space activities has emphasized the need for effective laws and policies on space activities not just on an international level, but also on the national level. The successful operation of space law, policies and institutions in a country relies on the presence of suitable professionals. Institutions that address the subject of space law and policy play an important role in promoting national expertise and capacity in this field.

In response to the recommendation of the Legal Subcommittee of the Committee on the Peaceful Uses of Outer Space at its forty-second session, in 2003, the Office for Outer Space Affairs invited a number of institutions to provide the Office with information on their programmes relating to space law. A directory of education opportunities in space law has been compiled based on the information received from those institutions and is updated annually.

This directory contains information on the respective institutions' areas of specialization, the educational programmes offered, the facilities available, the prerequisite qualifications, financial information, fellowship opportunities and opportunities for international cooperation, as well as reference to educational material easily available on the Internet. Addresses and contact points for further information have also been included.

For ease of reference the information has been arranged in alphabetical order by country. An effort has been made to present, as accurately as possible, the information provided by the responding institutions. However, programmes frequently change and users of this directory who are interested in a particular programme are urged to contact the institution for current detailed information.

The list of countries and institutions contained in this directory is not exhaustive and has been updated on the basis of the information received in the past year. The Office welcomes additional and/or updated information from Member States and education institutions teaching space law or space law related subjects and sources of information.

It is hoped that this directory will be of assistance and that it will promote cooperation among Member States and education institutions in relation to space law. In particular, it is hoped that information on education opportunities will assist developing countries in establishing indigenous capabilities in space law.

#### ACADEMIC PROGRAMMES

##### 1. Higher University Diploma in Space Law and Technology

This course is a postgraduate course designed specifically to build capacity in space law and other areas of law relating to space activities.

The academic curriculum is divided into four modules covering, inter alia, the basic concepts of international law and space law (treaties and non-binding legal

instruments), the “Space2030 Agenda”, Earth remote sensing, telecommunications, deep space, astronomical observation (the topic of dark and quiet skies), the militarization of space and the prevention of an arms race in space, international organizations, international cooperation, space agencies, “new space” and the participation of the private sector in space activities. Since the sustainability of space activities is a central element, participants in the course study the Sustainable Development Goals of the 2030 Agenda, the Guidelines for the Long-term Sustainability of Outer Space Activities and the Space Debris Mitigation Guidelines, as well as the applicable technical standards set out in the latter two documents for the design and deployment of space technologies and missions. In the light of the growing number of private-sector actors, topics such as national laws on the registration of objects, regulations in the area of science and technology, and intellectual and industrial property are also studied. Masterclasses led by guest lecturers are part of the study plan.

2. **Duration of the programme:** 122 hours of class days every Tuesday of every month.
3. **Period:** programme starts in April 2024 and ends in October 2024.
4. **Course Language:** Spanish. Some special presentations, talks by guest lecturers and parts of the teaching and academic material used as reference may be in English.
5. **Requirements:** National university degree (at least four years of study) or equivalent foreign qualification in law, engineering, international relations, biological sciences, business administration or a similar subject. Other qualifications may be considered.
6. **Course cost and grants:** The institution should be contacted directly.
7. **Modality:** Distance learning through a platform, combining real-time tuition and independent study (includes theory and practical classes).
8. **Final qualification/certificate:** Higher University Diploma in Space Law and Technology.

The postgraduate course in space law, policy and economics consists of 13 classes representing 40 hours of lessons and workshops. The main courses are: international, Latin American and Argentinian space law; space geopolitics; space economics; space mining; military uses and weaponization of outer space; space sustainability; international, regional and national space institutions; satellite telecommunication regulation and introduction to space technology. CIEE organizes professional visits to space centres in Argentina with the support of its partners. In addition, students may attend masterclasses and conferences. The academic team is composed of nine professors and two assistants, from the Department of Aerospace Engineering of the Faculty of Engineering, the Faculty of Legal and Social Sciences and the Faculty of Economic Sciences.

1. **Degrees offered in Space Law or related to space law:** While no specific degree programme on space law is offered, a specialization in the field of space law within the general law degree is possible in the framework of two elective fields of specialization, namely “Law of International Relations” and “Technology Law”. Furthermore, seminar papers, bachelor and master theses as well as PhD theses dedicated to space law related topics are supervised.

2. **Courses offered in space law or related to space law:** During each academic year, several courses are offered in the area of space law. A general course entitled “General Legal Framework of the Use of Outer Space Technologies” aims to provide an overview of the legal framework for activities in outer space and for the use of outer space technology. Moreover, students can participate in the “Manfred Lachs Space Law Moot Court” which forms part of an elective course, in which students also learn to write research papers related to the legal problems of the Moot Court case. In addition, seminars on international law dedicate parts of the programme to topics related to space law. International guest lecturers are invited on a regular basis. Study trips to the United Nations Office for Outer Space Affairs provide students with insights into practice. Furthermore, the Austrian National Point of Contact for Space Law (NPOC) of the European Centre for Space Law (ECSL) established at the Law Faculty of the University of Vienna organizes space law-related conferences, events and essay competitions in which students can participate.

The Master of Advanced Studies programme in Air and Space Law is a combination of public air law, private air law, and space law, both from an international, and European perspective. The programme has been running since 2000. As of 2005, a blended learning version of the programme is also offered. The programme is offered by the law school's renowned International Institute of Air and Space Law. The programme is designed for students who hold a full law degree, pursuing careers in law firms or in consulting firms having aviation and space law practice; legal departments of airports and airlines; aerospace companies; and civil aviation authorities, ministries or international, regional, and national organizations involved in aviation and space activities. A course in air and space law at bachelor's level is also taught in English in the framework of the "Leiden Law Courses", see: <https://studiegids.universiteitleiden.nl/en/courses/110831/aerospace-law>. 2. **Courses offered in space law or related to space law:** The subjects that are taught in the advanced LL.M. course include: Private Air Law, Public Air Law, Air Transport Competition Law, International Space Law & Policy, European and Commercial Perspectives of Space Law, Finance and Procurement of Aerospace Activities, and Moot Court Competition. Furthermore, students are required to do an internship and write a thesis. The programme is available in three versions:

1. Master of Advanced Studies in Air and Space Law (in residence). The programme is intended to be practically oriented, but it also pays due attention to fundamental and theoretical notions in air and space, European, public international, telecommunications, and competition law. It also focuses on the role and tasks of operators of infrastructure, including airports, and the subject of air traffic management.
2. Master of Advanced Studies in Air and Space Law (Blended Learning) Blended learning takes two years to complete and is a combination of distance learning, and face-to-face learning. Participants largely work from their homes or offices and communicate with the teaching staff through the Internet, using various new teaching techniques. Participants come to Leiden three times during the course for a period of two weeks in order to follow classical teaching sessions, and complete documentation. The blended learning version is only intended for established practitioners. Blended learners are exempted from the requirement of doing an internship.
3. Modular: All courses listed in the full-time programme (in residence) can also be taken on a single-course (modular) basis. In order to qualify for admission, prospective applicants must demonstrate an already existing

interest/participation in aviation and space activities. Certificates will be handed out after successful completion of a module.
